## TERMS & CONDITIONS

### APPLICATION AND ADMISSION

Application: Applications must be submitted as per the official forms enclosed herein. An application is valid only with a completed Application Form with the director's signature and Exhibits Registration.

The deadline for applications is May 31, 2019.

Confirmation: The Operation Committee will send the Exhibition Agreement to exhibitors by email. The Agreement will include the allocated space and further information on the payment. The Operation Committee reserves the right to revoke any accepted application if the exhibitor fails to comply with these regulations. The Operation Committee reserves the right to require the complete details of a proposed exhibit and prohibit the exhibition of any object that does not meet the requirements of the fair.

### PAYMENT

If the exhibitor does not pay the full exhibition fee according to the schedule, the Operation Committee reserves the right to reallocate their space to other applicants. Once the confirmation of participation is reported to the committee, participants will not be allowed to cancel their place; if participants do so, they will be assessed with 100% penalty.

### EXHIBITION SPACE USE

- a. No exhibitor may sublet or otherwise share any exhibition space either in whole or in part.
- b. No exhibitor may damage any facilities in the exhibition space (suite), drill holes or cause any other damage to hotel walls, otherwise exhibitors will be responsible for compensating any damage or loss of items caused to the hotel according to hotel policy.
- c. The exhibitor will be responsible for any extra hotel charges not covered by the exhibition fee.
- d. An exhibitor shall not display their artworks in the public area of the hotel. The exhibitor shall designate staff in the exhibition space throughout the fair and ensure the security of the artworks in the exhibition space. The Operation Committee will be responsible for the overall arrangements of exhibition spaces but not for the safety of the artworks in any exhibition spaces.
- e. An exhibitor shall not move any hotel furnitures or facilities unless authorized by the Operation Committee upon special requests.
- f. An exhibitor can display brand publicity ppt or videos by making full use of suite TVs and home theatres.

### SUITE USE

- a. Upon check-in, the exhibitor will be charged a deposit for any incidental charge that might incur. Final payment will be processed based on actual cost upon check-out.
- b. For any early arrival or extend stay, please make a booking request to the Operation Committee 1 month in advance. The Operation Committee will extend the group rate subject to rooms availability. Extra room charge will be covered by the exhibitor.

### SECURITY

- a. The exhibitor is responsible for any damage to artworks and equipment, thus, each exhibitor is recommended to obtain all possible forms of insurance coverage for damage and/or loss of artworks and properties during the fair. The organizer is exempt from any insurance responsibilities on any artworks or fair participants.
- b. The Operation Committee is not liable to any exhibitor for any damages or loss to artworks or property.
- c. All exhibitors must adhere to all fire, safety and security regulations enforced by the hotel, otherwise exhibitors will be responsible for compensating full or partial loss caused to the hotel based on hotel's price standards.

### FORCE MAJEURE

The Operation Committee is entitled upon the occurrence of events beyond the control of the Operation Committee including, but not limited to earthquake, fire, flood, civil unrest, war, strike, epidemic, economic or political unrest, or any other matter or cause beyond the control of the Operation Committee to cancel, postpone, or shorten the fair due to force majeure events, and in such instances, the exhibitors shall not be entitled to a refund of any payment made to Operation Committee nor to claim damages from the Operation Committee.

### EXHIBITORS' OBLIGATION

During the fair, the exhibitors shall adhere to all the exhibition regulations and rules. Exhibitors shall supervise their staff, invited guests and any other related parties such as transporters, installation companies etc. to ensure they adhere to the Art Jeju 2019 Regulations. If any action by these staff, invited guests or other related parties causes damage to the organizer or hotel, the exhibitors are responsible for all damage and any associated costs incurred.
